Please contact your ditchrider if you have any problems or questions. Your ditchrider **WILL NOT** telephone you every two weeks to notify you of your time. Please keep this rotation schedule. If there's a change from this schedule, your ditchrider will notify you. If you have an irrigator, please make sure they get a copy of the schedule. **IF YOU PLAN ON HAYING OR TURNING DOWN YOUR WATER FOR ANY REASON, IT IS YOUR RESPONSIBILITY TO NOTIFY YOUR DITCHRIDER OR THE DISTRICT OFFICE IN ADVANCE.**

SUBDIVISIONS: The District is not responsible for delivery to any point below and beyond those original points of delivery to the original tracts of land at which delivery was made as of October 4, 1966. Since the District is not responsible for the distribution of water to properties where the property has been divided into two or more parcels, it is important for all water users within these properties to work together in the spirit of cooperation in order that all users get their fair share. Water will be delivered to the original point of delivery for the allotted hours assigned to that parcel as a whole. Distribution of water beyond the delivery point is the responsibility of each water user within that subdivision. Hours allotted are to be shared by each water user. Failure to do so could result in a civil lawsuit between parties. The District will not be a party to such lawsuit. District personnel **WILL NOT** become involved in the distribution of water within a subdivision past the original point of delivery.

NOTE: IF YOU WANT WORK DONE ON YOUR DITCHES, CALL THE OFFICE TO PUT YOUR NAME ON THE WORK ORDER LIST, AND WHEN AND IF WE ARE IN THE AREA WE WILL TRY TO CALL YOU TO SAVE ON THE HAUL FEE.
